

## 8 steps to applying for a FAP full licence

This action plan sets out the key steps needed to apply for your Class 1 or Class 2 Financial Advice Provider (FAP) licence.

Use it to check your progress now and identify the steps you still need to complete to ensure you're ready to apply by the target date of 30 September 2022.
